Terms and Conditions

- **Payment currency:** All fees listed on the above are inclusive of VAT; billed and payable in USD (\$).
- **Due date:** Payments are due on the indicated dates/period.
- **Payment method:** Payments may be made through (a) Cash, (b) Cheque (c) Bank transfer or (d) Mastercard/Visa (for cash and cheque, please make an appointment in advance).
- **Information:** All invoices, statements and other billing correspondence will be generated in English. Parents needing clarification or assistance may approach our Student Recruitment staff directly.
- **Proration:** For new students joining in mid quarter/year, Tuition Fee will be prorated on weekly-basis and Capital Fee will be prorated on termly-basis.
- **Payment overdue above 30 days:** School will send a warning letter to the parents/guardians. Students may be excluded from examinations or assessment and may have their attendance privileges revoked until the outstanding amount is settled. The school reserves the right to disenrol a student with fees more than 30 days overdue and to refer the debt for recovery through legal action or third-party collection agents, including internationally where necessary.
- **Refund on withdrawal:** Refund will only be considered on submission of the completed withdrawal form and only for full term (tuition and capital) not attended - i.e., no partial quarterly refunds will be given. Administrative charges are deducted at 20% for Tuition and Capital Fee before refund.
- **Reservation of right to amend:** School reserves the right to change or add to this Fee Schedule from time to time for legal, safety or other substantive reasons or to assist the proper delivery of education at the school.
- **Students class allocation:** School reserves the right to allocate the students (existing and new) to their respective classes.
- **Force Majeure and Impossibility:** In this Fee Schedule “force majeure” means any event beyond a party’s control, including for the avoidance of doubt an epidemic or pandemic of any disease, strikes, other industrial disputes, war, riot, civil unrest, compliance with any law or governmental order, rule, regulation or direction (including that of a local authority), accident, fire, flood, storm, terrorist attack, chemical or biological contamination, failure of utility services or transportation, or any instances of impossibility of performance. If force majeure prevents or delays the school’s fulfilment of any of its obligations, including the ability to provide classes on its campus, the school shall give parents and legal guardians notice in writing specifying the nature and extent of the circumstances giving rise to the force majeure. If the School has acted reasonably and prudently to prevent and minimize the effect of the force majeure, the school will have no liability in respect of those obligations it is unable to fulfil for the duration of the force majeure. The school will not be responsible for making any refund of fees for education interrupted by such causes. The school shall make every effort to provide educational services for the duration of the force majeure, including but not limited to providing online learning opportunities.
